The ITU-T proposed meeting dates for Study Group 9 are May 5 -9, 2008 and for Study Group 12 the dates are May 22 – 30, 2008.

3.1 TR-30.1

Mr. Chu, TR-30.1 Chair, indicated that there is a statement in the report of the TR-30.1 meeting asking the TR-30 Chair to convey to UPED and TIA AWG issues with work taking place in TEITAC.
