## 5. Review and Approval of Meeting Report

The meeting report from this meeting, contribution 03.13.02, shall be circulated and approved by email after the meeting.

## 6. Correspondence and Liaisons

Tony Noerpel (Chair) reported that version 3.3.1 of the joint TIA/ETSI GMR-1 standard was published by ETSI in December of 2012 and is ready for endorsement by TIA. IPR and copyright language was resolved between TIA and ETSI for the joint endorsement of the TIA 1008B standard. This will be finalized at the next ETSI SES plenary in June, 2013. A Study Task Force funded by EC has been launched to study integration of satellite communications with Global Navigation Satellite Systems. This might be something TIA is interested in tracking.

Lars Erup (Vice Chair) reported on DVB, RCS and S2 activities. DVB-RCS2 has been finalized and is stable with mobility and mesh features and is going through the ETSI approval process. For DVB-S2 a carrier ID has been standardized and included in the specification, basically a CDMA carrier running under the information carrying carrier (DVB-S2 or other). This is actually independent of the DVB-S2 itself. It is in ETSI awaiting approval. This might be of interest to the TIA satellite community.

A new standard for DVB-S2 enhancements is being planned for the near term and a forward looking activity which may lead to a "DVB-S3" standard is also underway. The first round of proposals for new modcods have been introduced. These are being discussed. The range of Eb/No has been increased both at the low end and high end with additional proposed modcods. The next telecom is tomorrow March 22 at 9 am EST. A face-to-face meeting is planned for April 3-4 (in Geneva). The expectation is for this to be finished in the fall. In addition there are more radical proposals for additional modifications to the standard including OFDM, faster-than-Nyquist coding, and waveform features which might facilitate interference cancellation.

JIPM Joint IP Modem (JIPM) Interoperability Standard project - postponed. An update is unavailable but may become available within a month. The new update will include comment resolution of comments received from TIA previously.

The chair made a motion for TIA to co-endorse the ETSI GMR-1 3G version 3.3.1 standard. Lars Erup has seconded. Passed unanimously.

TIA action items for Lars Erup to continue to monitor DVB/ETSI activities associated with DVB-S2 and in particular the carrier ID standard and possibly introduce into TIA as a co-endorsement.

TIA action for Tony Noerpel to continue to monitor ETSI activities associated with GNSS for the possibility of introducing into TIA as a co-endorsement.
