**c. Review of Notice for Participation**

Exceptions to the foregoing may be granted or permitted in writing to the Chair of the Formulating Group by the head of the TIA Standards Department on a case-by-case basis.

Individual participants are encouraged to notify TIA of any patent(s) or published pending patent application(s) of which they are aware that may be essential to the practice of a proposed TIA Publication, including requirements introduced through normative references, early on in the development to reduce the possibility for delays in the development process and increase the likelihood that the proposed TIA Publication will become a Standard. However, a Patent Holder who has provided TIA with a TIA Patent Holder Statement with respect to the applicable proposed TIA Publication need not (but may elect to) identify its specific patent(s) or published pending patent application(s) that may be essential to the practice of the proposed TIA Publication in question. **4. Liaison Reports**

Yan Losier - ISED Canada does not impose accessibility requirements on products other than existing wireline. Following what the FCC is proposing on wireless devices, have a draft in process to harmonize with FCC. As of Dec 1<sup>st</sup> all wireless phones must be unlocked for no charge and have accessibility features (volume control).

Tony Jasionowski – ITI, Information Technology Institute; Section 508 was recently updated (refreshed) and references TIA-1083. VPAT updated the accessibility document to version 2.1. Works with GSA that covers all non-defense product purchases. GSA asks for the VPAT report. **CTA**, chair of the accessibility committee, new standard for NIBS to update an existing document for having more flexibility and harmonize with Japan Industrial Standard and ISO

Jim Bress – **Bluetooth HQ Audio**; Discussed the ongoing work for developing a High Quality Audio spec that will reference TIA standards for test methods.

Allen Woo – **ITU-T**: new working group SG12 WP1, Question 3. Writing standalone headset standards. New headset standard was drafted and Allen stated many concerns as written. Allen has become the new rapporteur for the standard. Going to be 4 standards, and 2 already published. More information to be presented in TR41.3.

Steve Whitesell – **EMC** standards; C63.19 may be balloted after the May 1 C63.19 meeting. C63.16 published a guide in 2016 on ESD testing. Been asked to extract a portion for IEC 61xxx-4-2. Jim (Bress) to be honored for work in accessibility by HLAA with a National Access Award.
