## 7. Review of Meeting Report from Previous Meetings

The TR-45 Committee 7-8 March 2012 meeting report numbered TR45/12.05.30.02 was reviewed. An omission in the meeting report on page 12 of 14 under agenda item 10.k was noted. The meeting report was amended to include the sentence "TR-45 recommends that TIA rescind for further study and refinement the TIA Standards Information Alert #002, "Changes to Online Document Forms and Process." A motion was made by C.Barber and seconded by O.Pearson to approve the revised meeting report provided in document .02r1. The motion passed with no objections. The Chair will provide document .02r1 to TIA for legal re-review prior to distribution.

## Action TR45-2012/05-01

The Chair will provide document .02r1, the revised 7-8 March 2012 TR-45 meeting report, to TIA for legal re-review prior to distribution and re-posting on the TIA website.

## 8. Reports

## 8a. TR-45.3 Subcommittee

There was no TR-45.3 report to TR-45.

## 8b. TR-45.4 Subcommittee

S. Sayeedi presented document .04 as the TR-45.4 report to TR-45 for information. The report indicated that there are eight TIA projects in development and three standards were approved for ANSI reaffirmation.

## 8c. TR-45.5 Subcommittee

O. Pearson presented document .05 as the written TR-45.5 report to TR-45 for information.

Regarding the joint ATIS/TIA Standard work on Coexistence and Interference Issues in Land Mobile Systems, the TR-45.5 report indicated that the joint work continues on the development of the P0017-v0.72 standard. Plans are to complete the baseline of Phase I in 2Q2012. The next JCOEXIST meeting is scheduled for July 23-24 in Spokane, WA.

Regarding NIST PAP2, TR-45.5 reported that updates were provided on the Wireless Capability Matrix for Guideline 2.0 as provided in document .28. Document .05d, a summary of SGIP PAP2 activities, was presented for information. It was reported that TR-45.5 is on track to have cdma2000 1x and HRPD "identified" in the SGIP Catalogue of Standards.

Documents .05b and .05c regarding outstanding publications were provided for information and reviewed. It was noted that TR-45.5 continues to work with TIA to address the outstanding publications and good progress has been made.

## 8d. TR-45.8 Subcommittee

B. Covell provided document .06 and its attachments as the TR-45.8 report to TR-45 for information. Regarding the JCMAS work, TR-45.8 reported that during the course of JCMAS deliberations no changes have been identified for the joint documents although changes are being made to the ATIS only specifications. Plus TIA TR-45.8 and ATIS WTSC G3GSN have agreed to initiate revisions of J-STD-100, J-STD-101-1, and J-STD-102 to address bug fixes that have been found since the documents were published.

TR-45.8 requested that TR-45 support a joint discussion between TIA TR-45.8 LIG and ATIS WTSC LI to look at Femtocell LI concepts. There were no objections to TR-45 supporting the joint discussion as presented in document .06. There were no objections to the correspondence provided in Document .11 to go forward to ATIS WTSC LI indicating that both TR-45 and TR-45.8 have agreed to support a joint discussion between TIA TR-45.8 LIG and ATIS WTSC LI to look at Femtocell LI concepts.

TR-45.8 reported that TIA TR-45.8 and ATIS WTSC G3GSN have agreed to initiate work on a new project for SMS to 9-1-1. The ATIS issue statement was provided in document .06b. It was noted that there is a new email distribution list for the joint SMS to 9-1-1 work (that includes the names on the JCMAS email list.) Members

interested in the joint SMS to 9-1-1 work were welcomed to join the new email list by contacting the TR-45.8 Chair.

Document .26 regarding TIA legal comments on TSB-1213/S.R0139-0 was provided for information to TR-45.

Action TR45-2012/05-02 Document .06b was remanded to the Subcommittees and Ad Hoc Groups for information.

Action TR45-2012/05-03 The Chair will forward the correspondence in document .11 to ATIS WTSC LI.

#### Action TR45-2012/05-04

Document .25 regarding notification of a 3GPP2 technical document was remanded to TR-45.8 to take action as appropriate.

#### Action TR45-2012/05-05

Relative to Action 45-2011/12-16 from the TR-45 meeting held 12-13 December 2011, TR-45.8 requested that any additional inputs regarding ITU-T SG-13 Recommendation Q.1742.10 be provided prior to its 21 June 2012 meeting.

#### 8e. Ad Hoc on Authentication Group (AHAG)

There was no Authentication Group Ad Hoc (AHAG) report. However, it was noted that there will be an AHAG report into the September 2012 TR-45 meeting to indicate the need for the reaffirmation of TIA-1048-A in January 2013. An item will be included on the December 2012 TR-45 meeting agenda to vote on the reaffirmation.

#### 8f. AHG on Electronic Media Documentation (AHEM)

There was no AHEM report.

## 8g. AHG on ESN/UIM/MEID (EUMAG)

Document .09 and its attachments were provided by G.Pellegrino as the TR-45 ESN/UIM/MEID Ad Hoc Group (EUMAG) report to TR-45 for information. The EUMAG recommended that TR-45 endorse the posting of TIA version 8.0 of the TIA Mobile Equipment Identifier (MEID) GHA (Global Hexadecimal Administrator) Assignment Guidelines and Procedures. There were no objections to TR-45 endorsing version 8.0 of TIA Mobile Equipment Identifier (MEID) GHA (Global Hexadecimal Administrator) 26 Assignment Guidelines and Procedures as provided in document .09ar1. Document .09ar1 will be posted on the TIA website. Document .09b was presented regarding the TIA MEID database development that is in progress. It was reported that the targeted implementation of Phase I is late 3Q2012 (after robust testing complete.) TIA will work with the current report recipients to transition to the web-based system (pending any legal or access considerations.) Document .14 was provided for information.

#### Action TR45-2012/05-06

The EUMAG Chair agreed to provide the TIA version 8.0 of the Guidelines and Procedures in document .09ar1 to TIA to post on their website.

#### • MEID Administrator's Report

J. Derr provided document .12 and attachments, MEID Administration Reports, for information.

## • UIM\_ID Administrator's Report

J.Derr provided a brief verbal report. It was suggested that this agenda item be modified going forward to reflect both ESN and UIM ID Administration.

## 8h. J-STD-025 Series Report

Document .47r1, the J-STD-025 Series status table, was provided for information by G.Pellegrino.

## • Status of J-STD-025, J-STD-025-A

Once again, it was noted that TR-45 agreed to take no action on J-STD-025. It was noted that J-STD-025 remains available through HIS. Status of J-STD-025 will be removed from this TR-45 agenda item going forward.

It was reported that TIA and ATIS coordinated the ANSI J-STD-025-A reaffirmation ballot close date of 14 May 2012. The ATIS ANSI ballot closed on 14 May 2012. The TIA ANSI ballot was extended to 28 May 2012. The TIA ANSI ballot to reaffirm J-STD-025-A closed on 28 May 2012 with a sufficient number of ballots returned to approve the reaffirmation. There were no ballot comments.

# • Vote to Approve for Publication of ANSI/J-STD-PN-025-A-RF1 (J-STD-025-A, "Lawfully Authorized Electronic Surveillance" - Reaffirmation)

A motion was made by G.Pelligrino and seconded by B.Covell to vote to approve ANSI publication of ANSI/J-STD-PN-025-A-RF1 (J-STD-025-A, "Lawfully Authorized Electronic Surveillance" – Reaffirmation) as provided in document TR45/12.03.07.49. The motion passed with no objections.

## Action TR45-2012/05-07

The Chair agreed to submit the Authorization for Publcation Form for ANSI/J-STD-PN-025-A-RF1 (J-STD-025-A, "Lawfully Authorized Electronic Surveillance" – Reaffirmation.)

## Action TR45-2012/05-08

TIA will coordinate with ATIS on the ANSI publication of J-STD-025-A, "Lawfully Authorized Electronic Surveillance" – Reaffirmation.

## • Status of J-STD-025-B AD-3

It was reported that TIA and ATIS coordinated the 45-day ANSI ballot close date of 6 July 2012 for Addendum 3 of J-STD-025-B. As indicated in document .31, the reaffirmation publication of J-STD-025-B, Addendum 1 of J-STD-025-B, and Addendum 2 of J-STD-025-B was completed. Document .31 was provided for information.

## 8i. OID Administrators Report

There was nothing to report. It was noted that G.Pellegrino would bring S.Montgomery up to date on the OID Administration issues immediately following the meeting.

## 9. Old Business

## 9a. Joint CMAS Standards Development Status

There was no additional information to report beyond that which was provided in document .06, the TR-45.8 report to TR-45, covered during agenda item 8.d.

## 9b. Joint Co-Existence and Interference Standards Development Status

There was no additional information to report beyond that which was provided in document .05, the TR-45.5 report to TR-45, covered during agenda item 8.c.

## 9c. Joint TIA/ATIS Publications

Documents .15 and .50 were provided for information. TIA requested that TR-45 review and confirm that the joint standards listed in document .32a should be archived. Based on the meeting discussion and the existing status information provided in documents .15a and .15b, document .32ar1 was drafted to indicate which joint standards TR-45 believes should be archived.

Action TR45-2012/05-09 The Chair will forward document .32ar2 to TIA.

## Action TR45-2012/05-10

Plans are to include on the September TR-45 meeting agenda an item to consider for withdrawal the joint standards listed in document .32ar2 that were developed under the purview of the former TR-46.

## Action TR45-2012/05-11

Document .32ar2 was remanded to the Subcommittee and Ad Hoc Groups for information.

## 9d. NIST PAP2 re: SGIP Catalogue of Standards Status

Document .28 that contains email from TR-45.5 to the NIST SGIP PAP2 regarding the Wireless Capability Matrix for Guideline 2.0 was provided to TR-45 for information. As indicated in document .05, the TR-45.5 report to TR-45 covered during agenda item 8.c, TR-45.5 continues to work to have cdma2000 1x and HRPD "identified" in the SGIP Catalogue of Standards.

## 9e. TIA Document Numbering Scheme

Document .29 was provided for information. Document .38 contains revisions to the proposed Annex J of the TIA Engineering Manual regarding the TIA Numbering of Projects and Documents. The revision of Annex J was provided for review and comment in preparation of voting for approval at the next TIA Technical Committee meeting on 2 August 2012 at 2:00 PM ET. It was noted that TR-45 has the opportunity to provide additional comments on the revision of Annex J. TIA has scheduled a conference call on 26 June 2012 to discuss the revision of Annex J. It was also reported that TIA will continue to operate under the original Annex J.

## Action TR45-2012/05-12

A small group (J.Brownley, B.Covell, O.Pearson, and K.Jang ) volunteered to generated (via email) a marked version of the revised Annex J that incorporates the existing TR-45 comments and concerns prior to the 26 June 2012 TIA meeting. A copy of the marked version will be provided to TIA for consideration and emailed to TR-45 for information.

Document .08 and it attachments were remanded to the Subcommittees and Ad Hoc Groups for information.

## 9f. TIA Republication Text

TIA provided status on their testing of a new process to allow the online Publication Authorization Form (PAF) to accept revised documents. It was noted that work continues on the new process. TR-45.5 and others were asked to continue to submit a second PAF with a note in the comment box regarding the reason for the resubmission.

## 9g. Distribution of Complimentary Copy of Standard to Ballot Voter

Document .19 contains email correspondence from TIA regarding the TIA decision to revert to the former process of sending complimentary copies of standards to ballot voters in unlocked pdf format, however, now with copyright disclaimers and other identifiable information as watermarks on the each page of the file. It was noted that document .19 previously was emailed to TR-45 members for information.

## 9h. ITU-R 5D Distribution List for External Organizations

Documents .16, .17, and .18 contain the series of emails from TR-45 to and from TIA to and from 5D regarding the updates provided from TR-45 to TIA on the 5D distribution list for external organizations. These documents were provided for information.

## 9i. Liaison from ITU-T SG11 Re: Feedback on Supplement 62 to ITU-T Q Series Recommendations

Document .27 contains TR-45.8 correspondence to ITU-T SG11 regarding a request for feedback on the draft revision of Supplement 62 to ITU-T Q series Recommendations. Document .27 was provided to TR-45 for information.

## 9j. ITU-R Recommendation M.1457-11 Updates

Document .30 contains TIA correspondence to ITU-R regarding TIA ITU M.1457-11 Letter of Conveyance. Document .30 was provided for information.

## 9k. OneM2M- M2M Global Initiative for M2M Standardization

Document .33 contains the TIA presentation on the new OneM2M – M2M Global Initiative for M2M standardization that was provided at the TIA TSSC and TC meetings in April 2012. Document .33 was provided to TR-45 for information. Attention was drawn to the launch schedule on slide 4. The first Steering Committee (SC) meeting will be in the U.S. 24-26 July. The second Technical Plenary (TP) meeting will be in China 10-16 December (which conflicts with the 3GPP2 TSG meeting dates.) Document .49 that contains the OneM2M meeting notice and invitation was provided for information.

#### 10. New Business

#### **10a. TIA Information Alert 004**

Document .20 contains the TIA Information Alert 004 on Public and Non-public Documents. Document .20 was previously forwarded to TR-45 members via email and a couple of concerns were raised. One concern was regarding encryption source code. The other concern was relative to posting TIA documents on the 3GPP2 meeting servers during co-located face-to-face meetings and subsequently uploading the documents to the 3GPP2 ftpsite. After some discussion and based on feedback from TIA, it was determined that there was no need to change the current TR-45 processes. The phrase "Unless otherwise decided by the Engineering Committee…" in Information Alert 004 allows for the TR-45 exceptions. Plus, it was agreed that TIA documents uploaded to the 3GPP2 ftpsite would also be uploaded to the TIA ftpsite.

#### 10b. TIA 2012: Inside the Network

Documents .21 (regarding the program schedule for TIA 2012), .39 (regarding standards and engineering committee events), and .46 (regarding TIA member events) were provided for information relative to the "TIA 2012: Inside the Network" event in Dallas, TX 5-7 June 2012.
