7. Review of Meeting Report from Previous Meetings

The TR-45 Committee 30-31 May 2012 meeting report numbered TR45/12.09.05.02 was reviewed. A motion was made by F.O'Brien and seconded by G.Pellegrino to approve the meeting report provided in document .02. The motion passed with no objections.

8. Reports

8a. TR-45.3 Subcommittee

J.Ragsdale, TR-45.3 Vice-Chair, presented document .03r1 as the TR-45.3 report to TR-45 for information. It was reported that Peter Musgrove of AT&T announced his resignation as Chair of TR-45.3. The TR-45.3 Vice-Chair agreed to serve as the Acting TR-45.3 Chair until the election is held for TR-45.3 Chair per Section 4 of the TIA Engineering Manual. It was agreed to recognize Peter Musgrove with a plague to express appreciation for his many years of service and support to TIA TR-45.3.

8b. TR-45.4 Subcommittee

S.Sayeedi, TR-45.4 Vice-Chair, presented document .04 as the TR-45.4 report to TR-45 for information. There was lengthy discussion on the open issue in document .04 regarding TIA normative reference language. A motion was made by S.Sayeedi and seconded by F.Quick for TR-45 to move forward via the TSSC to recommend the TR-45.4 suggested text changes to the TIA Style Manual regarding normative language. The motion passed with no objections. After further investigation it was noted that the normative language text (Section 2.3.3) provided by TR-45.4 in document .04 was not consistent with the approved 1992 version of the TIA Style Manuel. Thus the motion was subsequently rescinded with no objections. It was suggested that TR-45.4 use the normative language text in the approved 1992 version of the TIA Style Manual in order to move forward with publication.

8c. TR-45.5 Subcommittee

O. Pearson presented document .05 as the written TR-45.5 report to TR-45 for information. Document .34 was provided for information. Regarding the joint ATIS/TIA Standard on Coexistence and Interference Issues in Land Mobile Systems work, it was reported that work continues on the standard P0017-v0.72 and that TR-45.5 proposed text for Section 6.1, Out of Band Emission, was approved and submitted to the joint session held 23-24 July 2012.

8d. TR-45.8 Subcommittee

B. Covell provided document .06 and its attachments [A-F] as the TR-45.8 report to TR-45 for information. Attachments A, B, and D were provided for information. A report of the LIG Ad Hoc in Attachment E was presented for information. It was agreed that Attachment F that contains the LIG recommended ANSI J-STD-025-B-3 ballot comment resolution would be considered during the joint session scheduled for Thursday 04 October 2012 at 11:30am to address the ATIS joint LB-015 Nokia Siemens Networks (NSN) comments.

Action TR45-2012/09-01

Document .06F was carried forward to the joint ANSI J-STD-025-B-3 ballot comment resolution session.

Regarding JCMAS, plans are to initiate revisions of J-STD-100, J-STD-101-1, and J-STD-102 to address bug fixes that have been found since the documents were published. These revisions are planned to be approved for ballot at the end of September. In addition plans are to initiate work on a new project for Canadian Commercial Mobile Alerts Service (CMAS). The ATIS issue statement was provided for information in Attachment C.

Regarding JSMS911 work, it was reported that significant progress has been made. The reference architecture has been agreed, along with basic call flows, use cases and requirements. A number of system wide assumptions have been included in the document to clarify expected operation.

Document .56 was provided for information.

8e. Ad Hoc on Authentication Group (AHAG)

Document .07r1 was provided by F.Quick as the AHAG report to TR-45 for information. The reaffirmation vote of TIA-1091 "IMS Security Framework" and TIA-1098-A "Generic Bootstrapping Architecture (GBA) Framework" will be placed on the agenda of the December 2012 meeting of TR-45. In addition, a note will be placed on the agenda for voters to contact TIA at <u>standards@tiaonline.org</u> for a copy of the standard prior to the reaffirmation vote, if so desired.

The December 2012 TR-45 meeting agenda will include reaffirmation votes for TIA-1091 and TIA-1098-A.

It was reported that TIA-946-A "Enhanced Cryptographic Algorithms" is due for reaffirmation in May 2013. It was agreed that March 2013 TR-45 meeting agenda will include reaffirmation vote for TIA-946-A. Furthermore, it was agreed that TIA will ensure that the TIA-946-A reaffirmation draft text is available on a public website (i.e., such as the AHAG public folder) prior to the March 2013 TR-45 meeting and will submit the "TSU" notification to the U.S. Department of Commerce, if access to a copy of the standard is required prior to the reaffirmation vote at the March 2013 meeting of TR-45.

TIA will ensure that the TIA-946-A reaffirmation draft text is available on a public website and will submit the "TSU" notification to the U.S. Department of Commerce (per TIA legal), if a copy of the standard is required prior to the reaffirmation vote at the March 2013 meeting of TR-45.

P.Nurse provided document .08 for information. Document .15 regarding a proposal to modify the ftp site for TR-45.AHIMT was presented by P.Nurse. It was agreed by TR-45 to allow the AHIMT to make the changes to the ftp site as outlined in document .15.

P.Nurse was directed to move forward to make the changes to the TR-45.AHIMT ftp site as outlined in document .15.

8g. AHG on ESN/UIM/MEID (EUMAG)

Document .09 was provided by G.Pellegrino as the TR-45 ESN/UIM/MEID Ad Hoc Group (EUMAG) report to TR-45 for information. It was noted that the next JEM session is scheduled for 25 June 2013. An update on the TIA MEID database is planned for the next TR-45 meeting in December 2012.

J. Derr provided document .12, MEID Administration Reports, for information. It was reported that good progress has been made relative to MEID Administration.

• ESN and UIM_ID Administrator's Report

J.Derr provided a brief verbal report.

8h. J-STD-025 Series Report

Document .11r2, the J-STD-025 Series status table, was provided for information by G.Pellegrino.

J-STD-025-A-Reaffirmation was published 14 August 2012. Document .54 was provided for information.

• Status of J-STD-025-B AD-3

It was reported that the TIA ballot closed successfully on 6 July 2012 with no comments. The ATIS Letter Ballot closed successfully on 10 July 2012 with comments from Nokia Siemens Networks (NSN). Document .36 that contains the ATIS ballot comments on J-STD-025-B-3 was provided for information. It was reported that a joint TIA TR-45 and ATIS WTSC & PTSC meeting was scheduled for 4 October 2012 at 11:30am ET to address the ballot comments. A GoToMeeting notice will be proivded at least three weeks in advance of the joint meeting. Plans are to carry-forward document .06F to the joint session.

9f. OneM2M- M2M Global Initiative for M2M Standardization

Document .57 was provided for information. It was noted that the first Technical Plenary (TP) of oneM2M is scheduled for the week of September 24 in Nice, France. TIA will be represented at the oneM2M meeting. TR-45 agreed to suggest that TIA submit the two TR-45 published M2M documents (i.e., M2M Study and M2M Numbering Requirements) into the oneM2M TP meeting.

Chair's Note, it was uncovered after the meeting adjourned that there were indeed three TR-45 published M2M documents (i.e., M2M Study, M2M Requirements, and M2M Numbering Requirements) for submission to the oneM2M TP meeting.

The TR-45 Chair was empowered to contact TIA (C.Blum) to request that TIA liaise the TR-45 published M2M documents into the oneM2M TP meeting. The Chair will work with M.Bienn to generate a couple of paragraphs to include in the TIA LS cover to indicate that the standards are not for transfer but for information for consideration.

9k. Watermarks on Complimentary Copies of Standards

It was reported that as an action item from the last TIA TSSC meeting TIA would be hosting a conference call on Wednesday 19 September 2012 at 2:30 PM EDT for 1 hour to address an issue raised regarding the watermarks on complimentary copies of standards. A suggestion was made that the watermark on a complimentary copy be personalized to the voting member company, as apposed to the specific individual voter. Interested parties were welcomed to join the conference call. Document .52 was provided for information.

10. New Business

10a. Invitation to Update TIA TSB-10 "Interference Criteria for Microwave Systems"

At the last TIA Technical Committee (TC) meeting it was noted that TR-14 had changed its scope and charter such that older documents may best be worked in other groups. Microwave work may move to groups that already deal with RF such as TR-8 or TR-45 or a new Engineering Committee. Document .53 contains TIA TSB-10. TR-45 took an action at the last TIA TC meeting to review TSB-10 and to provide comments, if any back to the TIA TC and TSSC. Document .59 was provided as background information to help facilitate

discussion. There was lengthy discussion that raised several concerns regarding whether or not TR-45 is a good fit for TSB-10 without the specialized support. In addition, S.Nelson called into the meeting and provided additional information and addressed participants concerns. As a result a few options relative to TSB-10 were raised for further consideration and consultation with TIA.

Action TR45-2012/09-10

The Chair was directed to contact TIA to share the concerns and alternative options raised regarding the transfer of TSB-10 into TR-45.

10b. GSC Task Force Report on Emergency Communications

The GSC Task Force plans to complete the final report on Emergency Communications in 2013 (with a draft report completed by end of year 2012.) Plans are to use the report to simulate collaboration and coordination globally. The report will include not only Emergency Communications but will also include Public Safety aspects such as Alerts. Documents .35 and .58 were provided for information for consideration.

Action TR45-2012/09-11

Documents .35 and .58 were remanded to TR-45.5 and TR-45.8 for review and to generate inputs to the GSC TF report on Emergency Communications. The inputs should be provided to the TR-45 Chair to submit to the TF. Inputs are requested by end-of-year 2012.

10c. Recommendation to Vote to Publish PN-3-0335-A (TIA-1155, cdma2000 Network Performance Measurement Types)

The TIA ballot of PN-3-0335-A (TIA-1155, cdma2000 Network Performance Measurement Types) closed successfully on 19 April 2012 with no comments.
