# **Progress to Date:**

Four study tasks (E, G, M and N) are inactive due to lack of contributions. All other tasks have been quite active. All tasks except A, C and I are finished. Tasks C and I are expected to be completed shortly. Task A remains quite challenging. The main Task A issues revolve around modeling rain cells.

It was noted that the current document, TSB-10-F (Interference Criteria for Microwave Systems), will be upgraded to a TIA standard and will be numbered TIA-10-G.

- Project request needs to be created. (Published document number will be TIA-10-G).

A motion was made and duly seconded to open a project for TSB 10-F (Interference Criteria for Microwave Systems).
