  - phone software) if implemented for cdma2000 devices, or devices operating in a cdma2000 mode.
    - This topic will be handled by TR-45.5 (in conjunction with 3GPP2 TSG-AC).
- Do the operators want the cdma200 specifications updated or should we ask the FCC to leave the cdma2000
- 29 systems out of its mandate? TSG-AC is contacting the operators to gather additional information and will
- update TR-45.5 as additional information becomes available.
