#### 9b Status of the J-STD-025 Reaffirmation Ballots

J-STD-025-A, J-STD-025-B, J-STD-025-B-1 and J-STD-025-B-2, J-STD-025-B-3

#### 10a J-STD-038-B 14

- It has been several years since J-STD-038-B has been revised. A decision to withdraw or reaffirm the document needs to be made. Before that decision can be made, however, ATIS will be contacted to confirm this was, indeed, a joint project. (ATIS has no record of any activity since 2004.)
- Following the meeting, the Chair provided additional guidance:
  - (ANSI) We are clear that J-STD-038 is not an ANSI doc (but should confirm with ATIS). If it was, ANSI rules for reaffirmation or withdrawal would apply. But they almost certainly don't.
  - (J-STD) If J-STD-038 is a joint standard, are there rules for reaffirmation and withdrawal? I assume that TIA can't unilaterally do either, but maybe the standard can just sit there. However, I note that there was a Reaffirmation Notice in 2012, so presumably back then people thought reaffirmation was necessary.
  - (TIA) If J-STD-038 is not a joint standard, then presumably the identity of the standard needs to be changed (e.g. TIA-38 or something like that) and it will definitely need to be republished, and J-STD-038 will need to be withdrawn.
