**TR48-20121206-003**: TIA 2013 will be held in Washington DC on October 8<sup>th</sup> through 10<sup>th</sup>, 2013. Normally, TIA Engineering Committees will also try to have meetings at the same time. TR-48 had a face-to-face meeting in TIA 2012 in June. It is recommended that TR-48 will hold a face-to-face meeting at the TIA 2013. The proposed day will be October 10<sup>th</sup> (Thursday). The Chair would ask the membership to consider the offer from TIA 2013. The contribution is FYI for the group.

# 8. Liaison Reports

**FMCSA:** On the truck safety related business, the Highway Bill is normall –examined once every two years. The next review will be in 2014. May discussions on DSRC, Electronic onboard Recorder, Eectronic Driving Log for tranport safety, etc. were conducted; however, not much of decisions were made and the progress had been slow.

**ISO TC204**: The Chair, at the capacity of the Rapporteur of WG16 (protocol stadnards for Intelligent Transport Systems (ITS)), reported that there was a TC204 Meeting in October in Moscow; however, he did not make it due to visa issue. He was in the middle of the December meetin in Singapore while we have the TR-48 meeting. WG16 is preparing a series of ITS standards for publication.

**oneM2M**: The second oneM2M Technical Plenary (TP) meeting (TP#2) would be held in Beijing, China from December 10-14, 2012. The main activity in TP#2 would be to elect the Chair and Vice Chairs. Peter Nurse, Chair of TIA TR-50, is a strong andidate for the Chair positon. The Technical Plenary had installed two Working Groups, Requirements (WG1) and Architecture (WG2) in TP#2 and the WGs operated with weekly conference calls. If your

#### 9. Other Business

Steve Sill from USDOT provided an update on the DSRC test in Michigan. As reported in the October meeting, the DSRC test in Michigan will examine how the proposed 5.9GHz DSRC radio system used in the communications between the vehicle and the "roadside system (RS)" performs. The initial setting is to see if a Safety Pilot over DSRC can be concluded by August 2013. The results will be analyzed and published.

Following the publishing of the test results, there can be three possible outcomes from rule making's perspective: (1) No regulation will be pursued; (2) More studies required; and (3) Some Regulation will be pursued according to standard Regulatory Process based on the cost-benefit analysis. At present, USDOT has not issued any decision or further official comments on the DSRC test. The Chair would like to thank Mr. Sill's effort (on his vacation) to keep the group updated. [Note: Mr. Walton Fehr did try to join the call; unfortunately, we missed him due to the meeting ended earlier than usual.]

# 10. Schedule Next Meeting

The next monthly meeting will be held via GTM bridge, from 10:00AM to 11:30AM Eastern Time on Thursday, **February 7, 2013**.

Note 1: The meeting for 2012 has been scheduled for "Thursday morning 10:00am-11:30am Eastern Time, on the second Thursday, of the even months (Feb. Apr., etc.) of 2012. If there is a need for more meetings, we will call for "-bis" or "-ter" meetings between scheduled meetings. Moreover, the actual meeting date for the following meeting will be confirmed at the end of each meeting. If a meeting date needs to be changed, it should be within the range of the Thursday before or the Thursday after the scheduled meeting." The Chair had reported this result to TIA meeting coordinator.
