- There was some discussion regarding RESTful approach. The RESTful aspects have yet to be addressed in oneM2M. It was agreed to defer further action on protocol aspects until oneM2M have established a Working Group with responsibility for protocols. ;
- It was agreed that a report on the activities of oneM2M would be useful to members of TR-50;
- There is a potential need to understand the process of transposition of oneM2M Technical Specifications and Technical Reports;
- Chair took an action item to inform Cheryl of the need to provide additional document to the oneM2M pool.
