Individual participants are encouraged to notify TIA of any patent(s) or published pending patent application(s) of which they are aware that may be essential to the practice of a proposed TIA Publication, including requirements introduced through normative references, early on in the development to reduce the possibility for delays in the development process and increase the likelihood that the proposed TIA Publication will become a Standard. However, a Patent Holder who has provided TIA with a TIA Patent Holder Statement with respect to the applicable proposed TIA Publication need not (but may elect to) identify its specific patent(s) or published pending patent application(s) that may be essential to the practice of the proposed TIA Publication in question. Patent searches are not required to comply with the TIA Intellectual Property Rights Policy.

Marianna said the ballot for PN4957.210a would require 60 days to complete the TIA/ANSI date.

There was clarification of who represents Silver Spring Networks for balloting, as Jay Ramasastry was still listed as the voting representative for Silver Spring Networks. Marianna took the action to add Don Sturek to the list and remove Jay Ramasastry.
